### संशोधित निविदा सूचना

महानिदेशालय पत्र संख्या-८फ/क्यू०सी०-८३१/६५४१, दिनांक १८.१०.२०१६ द्वारा राष्ट्रीय स्वास्थ्य मिशन द्वारा वित्त पोषित **National Vector Borne Disease Control Programme** के अंतर्गत ०६ जनपदों- आजमगढ़, गोण्डा, रायबरेली, हरदोई, सीतापुर एवं मऊ के जिला/जिला संयुक्त चिकित्सालयों में १० शैथ्यायुक्त एवं ०५ वेन्टीलेटर युक्त पीडियाट्रिक आई०सी०यू० की स्थापना कराये जाने हेतु टर्न-की आधार पर उपकरणों के कय/स्थापना एवं क्रियाशील किये जाने हेतु निविदायें आमंत्रित की गयी थी।
