The Government of India is continuously striving for prohibition of sex selection before or after conception, regulation of Pre-natal Diagnostic Techniques and prevention of their misuse for sex determination leading to female foeticide, through effective implementation of the PC & PNDT Act, 1994. In order to strengthen partnership with civil society to facilitate effective implementation of the Act, a number of Non-Governmental Organizations (NGOs) have been sanctioned Grants-in-aid under PNDT-NGO Scheme. A list of such NGOs working in your State/UT with their project district indicated is enclosed.

In order to achieve desired deliverables, it is important that their activities are monitored at District level and their track verification reports are sent from time to time, to evaluate their activities for processing their request for release of next installment of grants-in-aid. In this context, this Ministry has been requesting District Appropriate Authorities for track verification reports of the NGOs working in their district but reports are not forthcoming.

I shall, therefore, request you to kindly instruct District Appropriate Authorities concerned to monitor the activities of the NGO working in their districts and send reports from time to time, particularly at the time of release of next installment of grants-in-aid, to facilitate appraisal of the activities of the NGOs by this Ministry.
